### 1.-GENERAL INFORMATION

The purpose of this "Privacy and Data Protection Policy" is to make known the conditions governing the collection and processing of your personal data by Spain Startup and Investor Services S.L to ensure fundamental rights, honor and freedoms, all in compliance with the current regulations that regulate the Protection of Personal Data according to the European Union

We need to have a legitimate basis for the collection and processing of your personal data, so below, we indicate all the details of your interest regarding how we carry out these processes, for what purposes, that other entities may have access to your data and your rights

### 3.-SECURITY MEASURES

#### What do we do to guarantee the privacy of your information?

Spain Startup and Investor Services S.L implement appropriate technical and organisational measures to ensure a level of security appropriate to the risk, including inter alia as appropriate:

- the ability to ensure the ongoing confidentiality, integrity, availability and resilience of processing systems and services;
- the ability to restore the availability and access to personal data in a timely manner in the event of a physical or technical incident;
- a process for regularly testing, assessing and evaluating the effectiveness of technical and organisational measures for ensuring the security of the processing.
- the pseudonymisation and encryption of personal data;

### 4.- PURPOSE

#### For what purpose will we process your personal data?

Spain Startup and Investor Services S.L will process your information to respond to the request made by the user who filled out our form. These requests are usually from users who are interested in our services and contact us in this way for us to inform them accordingly.

Also, through the registration forms on this website, data is collected, which is stored in a file, with the exclusive purpose of sending electronic communications, such as: newsletters, new entries (posts), as well as other communications that Spain Startup and Investor Services S.L understands interesting for its users

We use your information to provide our services, Event Organization. Startup competitions.

Only Spain Startup and Investor Services S.L will have access to your data. No data will be transferred to third parties except by legal obligation.

Here we detail the uses and purposes provided:

- E-Commerce: sharing information on social networks.
- Website inquires: Responds to inquiries received through different electronic forms
- Subscriber management: marketing, advertisement and commercial prospecting.
- Social Networks: Creation and management of information through social networks.

- Web Users: Respond to requests through the website Management and contact with users Customer management Ecommerce
- E-Commerce: Customer management

## For how long will we keep your data?

Personal data collected will be retained by Spain Startup and Investor Services S.L for as long as you decide. At any time you can exercise the rights that the data protection regulations make available to you. We reiterate that you can always delete your name from our database and the other rights recognized by the current regulations by contacting us through [mdelapena@auratechlegal.es](mailto:mdelapena@auratechlegal.es) or [privacy@spain-startup.com](mailto:privacy@spain-startup.com).

- E-Commerce: For a period of 5 years from the last confirmation of interest. The personal data provided will be kept as long as they are necessary or pertinent for the purpose for which they were collected or recorded, and as long as the consent given is not revoked.
- Inquiries: For a period of 1 year from the last confirmation of interest
- Subscriber management: As long as the deletion is not requested by the interested party
- Social Networks: As long as its deletion is not requested by the interested party. The personal data provided will be kept as long as they are necessary or pertinent for the purpose for which they were collected or registered. We are obliged to block the data when it is deleted. The blocking of the data consists of the identification and reservation, adopting technical and organizational measures, to prevent its treatment, including its visualization except for making available of the data to the judges and courts, the Public Prosecutor's Office or the Competent Public Administrations, in particular data protection authorities, for the requirement of possible responsibilities derived from the treatment and for three years. The blocked data may not be processed for any purpose other than that indicated.
- Web users: For a period of 5 years from the last confirmation of interest. The personal data provided will be kept as long as its deletion is not requested by the interested party and it is appropriate, and as long as they are necessary -including the need to keep them during the applicable limitation periods- or pertinent for the purpose for which they were collected or registered.
- Ecommerce customer management: For a period of 5 years from the last confirmation of interest.

## 5.- LEGITIMACY

### What is the legitimacy for the processing of your data?

ART 6.1.-B. GDPR. processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract;

ART 6.1.-A. GDPR. the data subject has given consent to the processing of his or her personal data for one or more specific purposes;

## 6.-RIGHTS OF INTERESTED PARTIES

### What rights do I have in terms of data protection?

- Right to request correction or deletion.

### What are your rights when you provide us with your data?

Any citizen has the right to obtain confirmation as to whether Spain Startup and Investor Services S.L is processing personal data concerning him/her or not. Interested individuals may access their personal data, rectify them or, if applicable, request the deletion when, among other reasons, the data is no longer necessary for the purposes they were collected.

You can also inform us about the limitation of the processing of your data in which case they will only be treated for the exercise or defense of claims.
